STATEMENT**

Privacy Statement

Vale Recreation Football Club ("VRFC") are committed to protecting and respecting you/your child's privacy. For any personal data provided for the purposes of you/your child's membership, VRFC is the Data Controller and is responsible for storing and otherwise processing that data in a fair, lawful, secure and transparent way.

What personal data we hold on you/your child

You may give us information about you/your child by filling in forms or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you register with the Club, or otherwise. The information you give us may include you/your child's name, date of birth, address, e-mail address, phone number, health information and/or other data.

Why we need your personal data

The reason we need your Data is to be able to administer your membership, and provide the membership services you are signing up to when you register with the club.

Reasons we need to process your data include:

For training and event entry

- sharing personal data with club coaches or officials to administer training sessions;
- sharing personal data with club team managers to enter events;
- sharing personal data with leagues, local associations such as Guernsey Football Association and other clubs/competition providers for entry in events.

For membership and club management

- processing of membership forms and payments;
- sharing data with committee members to provide information about club activities, membership renewals or invitation to social events;
- social media sites; promoting club activity; and
- publishing of VRFC results

Any special category health data we hold on you/your child is only processed for the purpose(s) of passing health data to the coaches to allow the safe running of training sessions. We process this data on the lawful basis of consent. Therefore, we assume that by providing this data on the VRFC registration forms for both existing and new players you are giving us your consent to process this data.

As part of the Player Registration process you/your child's information is passed to the Guernsey Football Association and/or the English Football Association, (via their Whole Game System portal). Both of these organisations and the Whole Game System have their own privacy policies and VRFC do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data to VRFC as part of the Player Registration process.

The club has social media pages i.e Facebook etc. All members are free to join these pages. If you join one of the social media pages, please note that the provider of the social media platform(s) have their own privacy policies and VRFC do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data on the club social media pages.

How long we hold your personal data

We will hold your personal data on file for as long as you are a member with us. Our data is updated every year on annual membership forms.

Your rights regarding your personal data

As a data subject you may have the right at any time to request access to, rectification or erasure of your personal data; to restrict or object to certain kinds of processing of your personal data.

As a data subject you are not obliged to share your personal data with Vale Recreation Football Club. If you choose not to share your personal data with us we may not be able to register or administer your membership.
